



Military Coup/ Treason? Is This the New Democracy?

Washington Post journalists Bob Woodward and Robert Costa released a new book, "Peril", which reportedly includes the actions of Gen. Mark Milley just days before the Nov. 2020 election, which appeared to describe a military coup.

- Article 77(1) (Principals),
- Article 81 (Conspiracy),
- Article 88 (Contempt Toward Officials),
- Article 94(a)(2) (Mutiny or Sedition),
- Article 104 (Aiding the Enemy),
- Article 106a(A)(1) (Espionage),
- Article 133(Conduct Unbecoming an Officer and a Gentleman),
- and Article 134 (General Article).

This bombshell book was apparently meant to talk crap about Trump, but what it seems to have done was to expose the kind of criminal activity the Democrats are willing to do with the help of the nation's military.
